# Topic 1.1 – Green energy transition and green hydrogen

The green energy transition, including green hydrogen, could play a significant role in Europe's and partners' energy resilience and decarbonisation efforts. It also presents an export opportunity for developing countries. Global Gateway has made good initial progress in developing projects on green energy and green hydrogen production in the Southern Neighbourhood, Namibia, and Chile; other partner countries such as India and Georgia are being engaged. Local value chains and win – win partnerships to address the triple challenge shared with partner countries of energy security, energy transition/decarbonisation and energy affordability are important. Local value chains such as green fertiliser and green steel are relevant for economic development, reducing the risk for a country of exposure to trade in a single commodity - but also mitigating risks for investors as the local economy and communities have a stake in the investments. Sustainability in its social, environmental, and economic dimensions is of central importance. Issues to discuss include:



- Energy supply partnerships and green energy development;
- Green hydrogen in energy supply chains trends, opportunities and challenges;
- Lessons to-date in combining public and private action for local production of green hydrogen;
- Key next steps and remaining challenges for Global Gateway.

# Topic 1.2 – Education and research

A defining characteristic of Global Gateway is its 360° approach, combining support for hard infrastructure with investments to develop the skills, regulatory frameworks and innovation that enable effective digital and green transformations. Global Gateway promotes a comprehensive approach to investment in education, research and innovation, addressing the capacity needs of all actors in order to strengthen people to people exchanges, build trusted networks in education and research and connect researchers and tertiary students between the EU and its partners. Innovation underpins Global Gateway and the green and digital transitions. Innovation in turn depends on the strong foundations of quality education and a strong research culture, based on critical thinking. Through Global Gateway, the EU will facilitate the mobility of students, researchers, staff and teachers and strengthen networks and peer learning. Issues to discuss include:

# Topic 2.2 – Transport corridors

Global Gateway aims to boost connectivity across all forms of transport (roads, buses and trams, trains, ports and shipping, airports). Issues to discuss include:

- The integration of the Western Balkans, Türkiye, Moldova, Ukraine and Georgia into EU connectivity networks providing the infrastructure to accelerate integration into the single market;
- How can Europe and Central Asia foster cooperation on the Transcaspian corridor?

Limited access to essential health products, exacerbated during the COVID-19 pandemic has demonstrated the importance of investing in national health systems, the security of supply chains and the development of local manufacturing and the right environment in order to foster resilience. Global Gateway can help increase production capacity, making demand more predictable, creating the right ecosystem for investment and enhancing healthcare systems, all while engaging the private sector to contribute to public health objectives. MAV+ is already working to build Africa's resilience to future health threats; the EU is also establishing a mutually beneficial partnership with Latin America and the Caribbean. Issues to discuss include:

- How to best combine public and private action for local manufacturing of health products.
- How to diversify value and production chains in order to respond to countries' public health needs.
- How to move to more comprehensive resilience in vaccines and other health products.
- Key next steps and remaining challenges.



## Topic 3.2 – Digital infrastructure



The COVID-19 pandemic has heightened the importance of access to secure and trustworthy digital infrastructures and technologies underpinned by proper regulation. Global Gateway digital infrastructure work under the 2023 priority flagships covers a wide range of actions, including: expansion of trans- and intra-continental connectivity, combined with greater data resilience and security; greening digital; last mile connectivity; data centres; and satellite connectivity. Issues to discuss include:

- Experience so far in mobilising public and private investment, including locally.
- How to ensure that the digital transition does not exacerbate inequalities.
- Continuing challenges (e.g. skills, national strategies, e-governance, international standards).
